- B. <u>Approval to Continue Open Enrollment for the 2020-2021 School Year</u> It is recommended that the district continue Open Enrollment for the 2020-2021 school year.
- C. Resolution Opposing the State of Ohio EdChoice Scholarship (Voucher)

 Program

It is recommended that the following resolution be approved:

Whereas, the Ohio legislature has recently made amendments which dramatically increases the number and availability of vouchers for students to attend private/parochial schools at public tax expense with no available research or accountability to support its positive effects, and

Whereas, such vouchers will be made available to families based on the district's local report card that continues to evolve and whose determining data set for this most recent expansion is five years old and in many instances inaccurately and unfairly designates a school as "failing," and

Whereas, the expansion of the EdChoice Scholarship Program had fewer than 300 eligible school buildings in 2018-2019 and will be expanded to nearly 1200 school buildings in 2020-2021, including many high performing school districts who regularly meet and exceed district report card expectations, and

Whereas, a school district's state funding will be unjustly decreased by the amount of vouchers provided to such families and students who have not and will not attend public schools and others who transfer to private/parochial schools, and

Whereas, private/parochial schools accepting students with public tax vouchers would not be required to accept all students but would be permitted to retain their selective admission policies without enforcement of other laws applicable to public schools, and

Whereas, there is no accountability system or testing standards in place for public tax dollars being used at private/parochial schools so that the actual performance of private/parochial schools subsidized with public tax dollars will not be known, relative to equivalent public school evaluation standards, and

Whereas, the State of Ohio has the constitutional responsibility to secure a thorough and efficient system of commons schools and EdChoice voucher program will have exactly the opposite effect by providing funding to private/parochial schools at the expense and to the detriment of public schools and their students.

Whereas, this Board supports a family's choice to seek a private/parochial school experience for their child and partners with local private schools by providing transportation and ancillary services to ensure quality learning opportunities for all St. Bernard-Elmwood Place students.

Now, therefore, be it resolved by the St. Bernard-Elmwood Place City School District Board of Education that this Board reaffirms its commitment to free accessible public schools which are adequately and equitably funded to guarantee a comparable education for all children and therefore opposes and respectfully requests the repeal of the ill-conceived EdChoice voucher program of the State of Ohio.

Be it further resolved that this Board opposes any funding programs, vouchers, or otherwise, that have the effect of diverting public tax dollars from public schools to private/parochial schools.

Be it further resolved that the Treasurer is hereby authorized and directed to forward copies of this Resolution to all Ohio state legislators, the Superintendent of Public Instruction, and the Governor of the State of Ohio.

D. Approval of Records Retention Procedures

It is recommended that the Records Retention Procedures be approved according to the Ohio History Connection School Recommended Retention Schedule.

E. Resolution Authorizing Membership in the Ohio High School Athletic Association

By resolution, the Board of Education of the St. Bernard-Elmwood Place City School District authorizes membership in the Ohio High School Athletic Association for schools under its jurisdiction. Schools eligible for membership are those that include one or more grades at the 7-12 level. It is agreed that these schools will conduct their athletic programs in accordance with the Constitution, Bylaws, Regulations, Interpretations, and Decisions of the Ohio High School Athletic Association. This resolution shall remain in effect for the school year 2020-2021.

F. Approval of Appointment to DART and Heritage Ohio Committee

It is recommended that the Board of Education appoint the Board Treasurer as the representative for the Downtown Assessment Resource Team and Heritage Ohio Committee.

G. 2020-2021 School Calendar
