WHEREAS, the Board is the owner of certain real property known as the Elmwood Place Elementary School (the "Property"); and

WHEREAS, upon the completion of the new St. Bernard Elementary School the Property will no longer be needed to provide services and education to the Students of the District; and

NOW, THEREFORE BE IT RESOLVED, by the Board of Education, that after careful consideration and evaluation of the information before it:

<u>Section 1</u>. The Board of Education hereby approves the sale of the Property, in accordance with the provisions of Ohio Revised Code section 3313.41.

<u>Section 2</u>. The Board directs the Treasurer to advertise the auction of the property in a newspaper of general circulation, specifically the Cincinnati Enquirer, for a period of thirty days.

<u>Section 3</u>. The Board of Education hereby finds and determines that all formal actions relative to the adoption of this resolution were taken in an open meeting of this Board of Education, and that all deliberations of this Board of Education and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22, ORC.

<u>Section 4</u>. This resolution shall be in full force and effect from and immediately after its adoption and shall supersede any prior resolution or act of this Board of Education that may be inconsistent or duplicative with the provisions of this resolution.
